Ordinances to Remember

Section 215.040 **Debris on Property - Effect of Failure to Remove Nuisance - Penalties.**

B. Owners or occupants shall be responsible for *maintenance of adjacent local road public right-of-way within the City of Hallsville*, including: 1. Properly mowing the grassed or vegetated area to prevent from being a public nuisance at seven (7) inches or more in height; 2. Trimming around all vertical objects; 3. Where present, sidewalks adjoining the property shall be maintained to control the growth of grass and weeds, both between the sidewalk joints and alongside both sides of the sidewalk and edge of pavement; 4. Where present, vegetation around curbs, gutters, culverts and catch basins shall be maintained to control the growth of grass and weeds, alongside of and between the curb, gutter, culvert and catch basin joints. 5. Clean-up of cut vegetation from road, sidewalk, curb, gutter, culvert and catch basin surfaces.

Section 210.1990 **Dirt and Debris on Streets, Sidewalks, etc.**

B. It shall be unlawful for any person, firm, co-partnership or corporation to place, deposit or cause to be deposited upon the streets of the City of Hallsville any mud, dirt, leaves, vegetative clippings, other organic matter, refuse, trash, automotive fluids, debris, or other similar matter in any roadway. C. Violation of this Section shall be a Class C misdemeanor punishable by a fine of not less than seventy-five dollars (\$75.00) nor more than three hundred dollars (\$300.00) or imprisonment in the County Jail not to exceed fifteen (15) days, or by both fine and imprisonment.

Drinking Water Primacy Fee: What does the Fee Do For You?

Every May you see the once a year water primacy fee (PF). The primacy fee is a user fee, paid by the customers of Missouri's public water supply systems and was initially established by state law. The fees are forwarded to the Missouri Department of Revenue for use by the Missouri Department of Natural Resources (DNR). The Department of Natural Resources uses the primacy fee to fund testing for drinking water contaminants, inspections, compliance activities, complaint investigations and technical assistance. The Missouri Department of Health and Senior Services receives an appropriation from the primacy fee for the Missouri State Public Health Laboratories bacteriological testing of water systems. DNR established new fee rates by amending rule 10 CSR 60-16 Drinking Water Fees, consistent with the process outlined in 640.100 RSMo. Last year the prorated fee for water meters under 1" was \$4.60 and this year they are \$5.28. Last year the prorated fee for water meters over 1" was \$16.48 and this year they are \$21.00.
